Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured. Our baseline carbon footprint assessment has calculated emissions across Scopes 1, 2 and 3 for the current (baseline) reporting year - 2022. These figures establish our starting point for measuring progress towards our targets.

BASELINE YEAR: 2022

Additional Details relating to the Baseline Emissions calculations:

The A24Group baseline emissions calculations were determined using the Normative Business Carbon Calculator and SSE Energy Solutions, which follows the <u>Greenhouse Gas Protocol</u>, the widely used international protocol for carbon accounting. The engine uses science-based emissions data and a combination of spend-based and activity-based methods to calculate a company's greenhouse gas emissions.

Each business activity that is input into Normative is paired with a corresponding emissions factor, which generates the calculation of its total carbon footprint:

Σ (Business activity × Emission factor) = Company Carbon Footprint

^{**} For these categories we have not measured the emissions as they are not relevant or material to our carbon footprint given the nature of our business or due to lack of direct control on data collection.


